CV 4.0 - Building for Generations Update



Sub-contractors are completing a list of 4.0 Building for Generations spring items. As pandemic guidelines evolve, we anxiously await our return to God's house. The Sanctuary is ready. Reinstallation of audio-visual and

streaming equipment is complete. Soon we'll be able to live worship in the Sanctuary, Great Commission Room, and Fellowship A-B-C simultaneously.

The new sanitary sewer installation is complete. This connects four building pipes to a larger pipe that moves waste into the city system. This upgrade alleviates a history of sewer backups and sewer line cleaning. Increased capacity will handle the increased volume caused by more toilets, sinks and a second kitchen.

Construction area asphalt as well as curb and gutter replacement is also finished. Sidewalks were put in last fall to facilitate a January temporary occupancy certificate. Safe entry was vital to occupancy certification. Little did we know COVID-19 would cause a pause in onsite worship.

Parking lot security and poor lighting has been an ongoing concern. Aligning scope with budget placed parking lights on hold until the project's conclusion. Church Council, at their May meeting, approved converting all parking lot lighting to LED, adding lower lot light capacity, and installing a new timer system. Work started in May and will finish by September.

We anticipate landscape and irrigation work to finish

up in early June. Our surveying firm will provide detailed design drawings and confirm the new ground water mitigation system meets Nine Mile Creek Watershed District performance expectations. Once these items are done Cross View's financial assurance payment will be returned. Church Council appreciates members submitting "Wish List" ideas. Staff and Council members review "Wish List" items monthly. Please contact Scott Douglas at sldouglas1@icloud.com or any Council member with your suggestions. "Wish List" expenditure decisions rest with the Church Council.







Financial Update

Year-to-Date Results

- April year-to-date income was 7%, or \$34K less than budget year-to-date.
- Expenses continue to be managed tightly, especially at this time when the building is closed to worship and programs. As a result, expenses were also less than budget, resulting in a year-to-date surplus of \$48K. The surplus does not include expected CARES Act Paycheck Protection Program (PPP) loan forgiveness of \$68K for Cross View as of April 30.
- The ECC is operating with reduced students and associated tuition, resulting in a year-to-date deficit of \$7K. Expected PPP loan forgiveness totals \$77K for the ECC as of April 30.
- The PPP loan continues to be used as required in order to be forgiven. The loan allowed us to maintain full payroll. Without the loan staff reductions would have occurred. We are grateful for the donations received from our members and guests, but future giving to Cross View and tuition for our Early Childhood Center remains

- very uncertain. God has been good to Cross View for 50 years. We continue to put our trust in Him to guide us through all things.
- Church Council is happy to report that our independent financial auditor has reviewed 2019 Cross View and ECC financial results and issued a positive report with no discrepancies. There are no material changes to our 2019 reported financial results. Thanks to our amazing financial and administrative staff and to our Church Council Treasurer, Linda Baule.

- 4) What good were we able to do (or could we do) around here?
- 5) How can we help you in prayer?



POBLO CONTINUES CONTACT

POBLO missionaries Nadar and Georgette Alajar continue to be in contact with over 25 students from the various International Friendship Center locations. With no meeting at the centers, contact needs to be made by phone. They support the students with personal encouragement and prayer, as well as practical help. Within the past month, they helped three students through applications for unemployment benefits due to Covid19. They have also begun in-person Christian education with a mother (a Christian) and her Muslim daughter. The Alajar family (3 young children and Nadar's father) remains well. Cross View has supplied their family with facemasks made by Cross View sewers. Please keep them in your prayers as their ministry continues.

Last month, there was a cry for help from our brothers and sisters in Los Vasquez, Guatemala. Los Vasquez is the small village in Guatemala that Cross View has adopted. They too are suffering from the COVID-19, pandemic. There are multiple families without food.

Our Cross View, Guatemala mission team was notified of this great need and was quickly able to raise \$1,730.00. This allowed the at-risk families



in Los Vasquez, to each receive: 100 pounds of corn, 15 pounds of beans, 10 pounds of rice, and a two-liter bottle of cooking oil. This amount of food will provide two-weeks of food for a family of eight.

The following is a letter of thanks from Los Vasquez for the food Cross View was able to provide:

Receive a cordial and attentive greeting from the neighbors of the Los Vasquez Taguayni Village, hoping that God our Lord will bless you fully wherever you are.

By this means I want to thank God first of all for his infinite mercy and at the same time thank you, Cross View Church, for the help in providing these necessities sent to our community through CALMS. This aid being brought and distributed by Mr. Helio Ramirez, who has put efforts in the villages and the rest of the municipality to help those most in need, as a volunteer for his organization. This aid was for all the 60+ year-old seniors of our community with or without family, each of these people and their families being directly benefited who were in anguish for not having the food or the means to obtain it. I am thankful for the support sent to the village Los Vasquez on May 11, 2020, of which I am a witness that it was carried out on that date, the groceries being delivered to each person.

I say goodbye to you hoping in God to see you again, but especially trusting in Our Lord Jesus Christ that you will be filled with blessings. Thank you very much brothers and sisters in Christ of Cross View Church in the United States.

Please keep the people of Los Vasquez, in your prayers, that they may be spared further from the pandemic. MISSION UPDATE FROM LINC TWIN CITIES

"Thank you for helping us to raise up even more leaders to reach even more people in the Twin Cities with the Gospel." Pastor Ben Griffin says, "As you know we have Gospel centered work happening in many different pockets of the city. As we raise up indigenous leaders to reach their own communities with the Gospel, we are now working with over 85 leaders representing 13 different people groups. We are planting churches, starting a





home for victims of sex trafficking, launching a home/church for men coming out of incarceration and much, much more. The church plant training and next generation conference that were held at Cross View last year were a huge boost to this work."

At this point in time Cross View's funding is being used to deploy new LCMS ministry efforts to reach the large Hmong community in the Twin Cities. There is a couple who will both be starting seminary education this fall and working with the Hmong community to start this ministry. Funding from Cross View is helping to build their ministry plan, their time and their circle of support. They are still in the early stages at this point so not much can be shared, but prayers are asked for.

Some other ways that Cross View members could help are:

- 1) We would like someone to become a coach to walk with a leader.
- 2) We have a training center that requires some skilled hands to do renovation. Also, some "unskilled" hands to assemble equipment and paint.

MISSION UPDATE FROM DR. FUNG LO AND FAMILY IN THAILAND



Dr. Fung Lo and family are serving by doing Hmong Ministry in Thailand. Right now, Cross View funds support the ministry of the Lo family to seek and save the lost at any cost. We are working to build up the church here in Southeast Asia among the Hmong People. Many have been living in Thailand since the

1970's and are mostly animistic. Without Cross View's financial support and prayers, it will be difficult for us to meet our financial budget needed for the Lord's mission work. Salvation is a free gift, because Christ has paid the full price for it on the cross, but mission work is very costly. It costed Jesus's life.

Cross View's funding goes specifically to towards the training of Hmong pastors and evangelists to witness the Gospel in Thailand, Laos, and Vietnam. It goes towards helping the Hmong women become Biblical spiritual leaders in their homes and communities. It also goes towards helping the Hmong children at their children center to experience the love of Christ through Bible studies and by serving others.

Some other ways that Cross View members could help are:

- 1) When it is safe to travel again, we would like to have a team from Cross View to come over to assist help us through some service projects.
- 2) Pray for those Hmong that are persecuted. This photo shows an elderly, who was beaten and kicked out of her home because she received Jesus as her Lord and Savior. This happened in March of this year. Many Hmong Christian individuals and families are facing persecutions in Vietnam and Laos.

Last month the larger group heard a presentation by Kay King of the National Alliance on Mental Illness (NAMI) on the subject of suicide prevention. Having suffered the suicide of close friends and relatives herself, Kay knows her subject well and is powerfully motivated to help provide solutions. She shared many statistics, exploded a few key myths, and shared the Question, Persuade, Refer (QPR) methodology of dealing with suicidal individuals. Suicide is one of the most preventable kinds of death, and almost any positive action may save a life.

Voters' Assembly Meeting Minutes January 19, 2020

1. Opening (Lynn Pahl, President)

- Meeting called to order at 12:10 p.m. and opened with prayer.
- 68 voting members signed in for the meeting and constitute a quorum. A simple majority will decide all decisions.

2. Approval of Minutes (Lynn Pahl)

- Voters' Assembly Meeting Minutes: May 19th, 2019
- <u>Motion</u> by Erik Kelly and seconded by Brad Ost to approve the May 19th, 2019 Voters' Assembly Meeting Minutes as written. Motion passed unanimously.

3. 2019 Cross View Preliminary Year-End Financial Results (Lynn Pahl)

- Background: 2019 budget was 9% increase YOY from 2018 budget.
- Actual 2019 YE receipts slightly under budget but expenses also under budget, resulting in \$57K YE net surplus. Surplus will be retained and spent on high priority needs in 2020 as determined by Staff, Council and the Building Chairman. 2019 receipts do not include Capital Campaign receipts.
- Drivers of YE favorability: debt service (\$25K favorable); Christian Ed (\$24K favorable); Wages (\$13K favorable); Marketing (\$9K favorable).
- Increased receipts and giving primarily came from: members fulfilling their annual operating pledges; members contributing who hadn't pledged annual operating amounts; and new members.

4. 2019 Early Childhood Center (ECC) Preliminary Year-End Financial Results (Lynn Pahl)

- 2019 ECC income and expenses slightly below budget with YE \$600 unfavorable.
- Stacey LaMere managed many changes throughout the build. Maintained great communication with staff and parents; families have stayed enrolled.
- Stacey pleased with the build process and outcome.

5. 2020 Cross View Budget (Lynn)

- 2020 balanced budget of \$1,352,349 presented. Budget is built through pledges; forecasting with historical
 and forward-looking giving and expense patterns; and faith. Challenge in planning is that significant portion
 of contributions come in last 2 months of the year and advanced pledges consist of only about 50% of
 receipts.
- 2020 budget is 15% YOY increase from 2019 actual receipts, which won't be easy.
- Three primary 2020 expense drivers of \$225K increase: 1) interest for remaining bridge loan and \$3M long-term loan (\$116K); 2) wages for: Director of Music; PT music person; and FT janitor (\$59K); and 3) higher utilities and insurance (\$47K)
- 2020 will be a year "restrained expense" management.
- Outreach & giving expenses: 8% of receipts to District and Synod; 2% of receipts to other outreach.
- Going forward, will request that large budget recipients provide reports of fund use.

- Current General Fund Surplus: \$224K (which includes 2019 \$57K surplus).
- <u>Motion</u> by Brad Ost and seconded by Matt Salzwedel to approve the 2020 Cross View budget. Motion passed unanimously.

6. 2020 ECC Budget:

- 2020 balanced budget of \$1,320,992 presented.
- Includes 2.9% avg tuition rate increase; expect new income due to new room addition with build.
- Includes \$25K interest contribution for Cross View expansion debt service due in 2020; ECC contributed \$9K to offset interest expense in 2019.
- Total possible enrollment: 92/day capacity; 88 currently enrolled due to part-time children. Generally have a waiting list.
- <u>Motion</u> by Brad Ost and seconded by Jonathan Zellar to approve the 2020 ECC budget. Motion passed unanimously.
- Stacey LaMere was commended for her good leadership.

7. <u>Building Update</u> (Scott Douglas and Lynn Pahl)

- Capital Campaign: 85% of pledges collected with \$610K outstanding; every dollar is essential and appreciated.
- Build has been a journey of prayers, patience and problems, i.e.: wettest summer on record; challenging worker availability; worker over-extension by contractors. We bid the project at a good time when costs were lower. Thank you for all of the trust, prayers and support to bring more people to Jesus.
- Total project to be completed in 29 days, on Ash Wednesday.
- 85% of expenses have been paid out; had to defer some things to spring. Sewer repair will be completed in June. Managing to budget with small contingency.
- New expansion occupancy target date: March 1st

8. Endowment Fund Update (Cal Kuhlman)

- Fund originally established in 1996 with LCEF account. Management of fund was cumbersome as several committees involved.
- Current account balance \$38K balance in LCEF account; \$9K interest available to use.
- Evaluating changes to Endowment Fund; plan to hold Town Hall Meetings in Feb/March to get congregational feedback.
- Future decisions will need to be made by the Voters; recommendations will be brought to a future Voters' Meeting.
- Thank you to Cal Kuhlman, Vern Hanson, Lyle Anderson and Renee Kirchner for working on this.

9. <u>Council Member Openings</u>: (Cal Kuhlman)

- Soliciting 2-4 members to fill open two-year term Council positions, effective June 1, 2020.
- Speak with Lynn Pahl, or any Council member, if interested and/or to learn more.

RESOLUTION RATIFYING PPP LOAN

WHEREAS, due to the possible health effects associated with the spread of COVID-19 the Governor of the State of Minnesota implemented an executive order having the effect of preventing Cross View Lutheran Church ("Cross View") from holding traditional worship services and educational programs, as well as holding a meeting of the Voter's Assembly for any purpose whatsoever; and

WHEREAS, Covad-19 together with the executive order of the Governor of the State of Minnesota had caused a sharp decline in enrollment and consequentially tuition payments to the Early Childhood Center; and

WHEREAS, on March 27, 2020 the United States Congress passed and President Trump signed into law the Coronavirus Aid, Relief and Economic Security Act ("CARES"); and

WHEREAS, CARES provides relief, benefit and stimulus measures designed to help Americans, businesses, nonprofits, and state and local governments during the coronavirus crises; and

WHEREAS, Cross View was eligible to participate in what is called under CARES the Paycheck Protection Program ("PPP"); and

WHEREAS, a loan under PPP is to be used for such things as payroll costs; paid sick, medical, or family leave; mortgage interest; and utilities (collectively herein, the "Designated Purposes"); and

WHEREAS, a principal amount of the PPP loan is eligible for forgiveness if the loan proceeds are used for the Designated Purposes; and

WHEREAS, due to the unprecedented nature of the coronavirus crises, on April 3, 2020 the Church Council determined the PPP loan was necessary to support the ongoing operations of Cross View.

NOW THEREFORE, the Church Council respectfully requests approval of the following resolutions:

RESOLVED, that the Voting Members approve and consent to entering into a loan transaction with Bremer Bank, National Association wherein Cross View obtained a PPP loan in the principal amount of \$373,213.88.

RESOLVED FURTHER: that all actions of Cross View and of the officers the Cross View which were taken or adopted prior to the date hereof with respect to the PPP loan, be, and the same hereby are, approved, ratified and accepted in all respects.

WHEREAS, the Voting Members of Cross View Lutheran Church have heretofore adopted Article XII of the Bylaws of the congregation establishing a congregational endowment fund and providing for the investment and administration of the fund;

WHEREAS, there are administrative provisions in Article XII which are either obsolete by reason of the restructuring of the governance documents of Cross View, or are otherwise unduly cumbersome because of unforeseen changes of circumstances; and

WHEREAS, the Council of Cross View deems it to be in the best interest of Cross View to amend Article XII of the Bylaws so as to, among other things, eliminate confusion, provide for consistency in terminology with other articles of the Bylaws and allow for improved controls and use of the endowment fund income.

NOW THEREFORE, the Council hereby moves that the Voting Members at a duly called meeting of the Voters' Assembly amend and restate Article XII of the Bylaws so as to read and provide as follows:

ARTICLE XII Endowment Fund

Section 1. Name. This congregation shall have a congregational fund, which shall be called CROSS VIEW LUTHERAN CHURCH ENDOWMENT FUND (herein, the "Fund").

Section 2. General Purpose.

- A. This Fund's purpose shall be to receive gifts and bequests, and to use them for the mission and ministry of CROSS VIEW LUTHERAN CHURCH ("Cross View"), and THE LUTHERAN CHURCH MISSOURI SYNOD, its districts, seminaries, colleges, instruments or agencies.
- B. The income from unrestricted gifts and bequests to the Fund, as well as the principal from the unrestricted gifts, is to be used for the uses, projects and programs recommended by the Church Council, provided they are consistent with the general purposes for which this Fund has been established.
- C. Gifts and bequests may be made upon special terms or conditions or containing limitations or directions as to the investment or use of the substance of the gift, and/or the use or accumulation of the income, provided that such are acceptable to the Church Council. Before accepting a restricted gift, the Church Council shall consider whether the gift furthers Cross View's mission and whether it can faithfully carry out the terms of the gift.
- Section 3. <u>Duration</u>. The Fund shall continue in existence and be used as hereinabove provided, unless earlier revoked, so long as Cross View shall continue to exist. If

Cross View dissolves and at such time the Fund is being managed and administered by the Church Council, then the assets constituting the Fund shall become the property of THE LUTHERAN CHURCH MISSOURI SYNOD FOUNDATION (the "Foundation") (except that any and all properties held by the Fund upon special conditions, restrictions or limitations shall continue to be subject to the conditions, restrictions or limitations upon which such properties are held). If upon dissolution of Cross View the Fund is managed and administered by the Foundation or other third party under an agreement providing for the same, then the terms and conditions of the subject agreement shall control in regards to the disposition of the Funds.

Section 4. Governance.

- A. The Fund shall be owned, managed and operated by the Foundation under an agreement with the Foundation with terms and conditions acceptable in all respects to the Council. Should any person or firm other than the Foundation own, manage or operate the Fund, then as a condition to entering into an agreement with such a person or firm the Council shall obtain the approval of at least 67% of the Voting Members present at either a regular or special meeting of the Voters' Assembly.
- B. The Church Council, directly or indirectly, shall be responsible to encourage members of the congregation to contribute assets to the Fund. The Treasurer of the congregation, directly or indirectly through Cross View's financial staff, shall be responsible for receipts and disbursements from the Fund, shall maintain complete and accurate books of accounts in regards to the Fund.

Section 5. <u>Duties of Council</u>.

- A. The Treasurer shall, at least annually, render to the Voters' Assembly at a Voters' Meeting an account of the Fund during the preceding year.
- B. Gifts and contributions in money, in securities, or in any other form of property, including, by way of explanation and not in limitation, direct gifts for the purpose of the Fund, gifts in memory of any deceased person in appreciation or recognition of any living person, gifts in the form of a devise or bequest under Will or trust instrument, and gifts or proceeds or portions of proceeds of insurance, annuity, or endowment policies or contracts, may be received by the Treasurer for distribution to the Fund at any time.
- C. Means of acknowledging the receipt of each gift and contribution shall be established and maintained by the Treasurer, directly or indirectly through Cross View's financial staff, including, whenever feasible, a designation of the value ascribed to each gift.

- D. Gifts and contributions may be made upon special terms or conditions or containing limitations or directions as to the investment or use of the substance of the gift, the use or accumulation of the income provided that such are acceptable to Cross View, as determined by the Church Council, and the Foundation. Separate identification and recoding shall be made of all transactions with respect to any special or restricted gift or gifts.
- E. The Church Council is to inform the members of the congregation of the purpose of the Fund, and may periodically arrange for members of the congregation to meet with professional counselors in the areas of charitable giving, Wills, bequests, insurance.
- Amendments. Any other provisions of Article XII of these Bylaws to the contrary notwithstanding any amendment to Article XII of these Bylaws, which will change, alter or amend the general purpose for which the Fund is established shall be adopted only if approved by 67% of all Voting Members present at a properly convened meeting of the Voters' Assembly, the notice of which has stated that such an amendment will be proposed to the Voters' Assembly.

RESOLUTION TO MEET BY ELECTRONIC COMMUNICATION

WHEREAS, the Church Council deems it to be in the best interest of the congregation to be able to hold meetings of the Voters' Assembly where the Voting Members may participate by electronic communication.

NOW THEREFORE, the Church Council recommends that the Voting Members approve and consent to amending Section 1 of Article III of the Bylaws by adding thereto the following new Section 1.1:

- 1.1 Meeting by Means of Electronic Communication. The Church Council has the option, but not the obligation, to hold any meeting of the Voters' Assembly where the Voting Members may participate by means of electronic communication. Should the Church Council elect to hold such a meeting, the Voting Members may participate by any means of communication by which all persons participating in the meeting can simultaneously hear and respond to each other. Participation in a meeting pursuant to this subsection 1.1 shall constitute presence in person at such meeting. The Secretary shall implement reasonable measures to verify that each Voting Member deemed present by means of remote communication and entitled to vote at the meeting of the Voters' Assembly is a Voting Member.
 - **1.1.1** If the communication technology allowing for remote participation by a Voting Member lacks a confidential ballot voting mechanism, a Voting Member's vote may nonetheless be recorded by the Secretary, but otherwise kept confidential.
 - 1.1.2 In the event of a communication technology failure occurring at any time during the course of a meeting of the Voters' Assembly wherein the Voting Members were given notice that they could participate by remote communication, and if such failure prevents any Voting Member from participating in the meeting, then (a) the Secretary shall determine if those actually present at said Voters' Assembly would be sufficient to constitute a quorum; and (b) if there is a quorum, then only those Voting Members present may continue to conduct business until the meeting is adjourned.

RESOLUTION TO SEND NOTICES OF VOTERS' ASSEMBLY MEETINGS BY ELECTRONIC COMMUNICATION

WHEREAS, the Church Council deems it to be in the best interest of the congregation to be able to notify members of Voters' Assembly meetings through forms of electronic communication.

NOW THEREFORE, the Church Council recommends that the Voting Members approve and consent to amending Section 4 of Article III of the Bylaws by adding thereto the following new Sections 4.1 and 4.2:

- 4.1 Any notice given to Voting Members under any provision of these Bylaws by a form of electronic communication consented to by the Voting Member to whom the notice is given is effective when given. The notice is deemed given:
 - **4.1.1** if by facsimile communication, when directed to a telephone number at which the Voting Member has consented to receive notice;
 - **4.1.2** if by electronic mail, when directed to an electronic mail address at which the Voting Member has consented to receive notice;
 - **4.1.3** if by a posting on an electronic network on which the Voting Member has consented to receive notice, together with separate notice to the Voting Member of the specific posting, upon the later of: (a) the posting; and (b) the giving of the separate notice; and
 - **4.1.4** if by any other form of electronic communication by which the Voting Member has consented to receive notice, when directed to the Voting Member.
- 4.2 Consent by a Voting Member to notice given by electronic communication may be given in writing or by authenticated electronic communication. The Corporation is entitled to rely on any consent so given until revoked by the Voting Member, provided that no revocation affects the validity of any notice given before receipt by the Secretary of revocation of the consent.
